- **Secretary's Report:** Report was printed and posted to the website. Motion to accept May 2026 minutes, all in favor.

Committee Report

- **Activities:** We are still looking for a replacement chair.

 - **Anniversary Dinner** – September 26th Zem-Zem Club. Speaker Tami D. from Area 60. More details to follow. The cost of tickets is \$30 each or \$50 for 2.
 - **Trunk or Treat** – October 25th
- **Public Information:** Alyssa was present. The 2 events in May went smoothly and AA was represented well. It was discussed that Alyssa is keeping our Traditions in mind and she is making a conscious effort to keep it to “attraction rather than promotion.” June 12th Erie County Drug and Alcohol Conference is at Millcreek Community Church.
